How to Seek CLE Credit from Your State

(Updated April 2024)

General Instructions:

We have created a guide on how to obtain CLE credit from your state based off of ELI's research. Please double check your state's requirements on your own so you do not miss a deadline, as CLE policies may have changed since ELI conducted its research.

Does Your State Have Mandatory/Minimum Continuing Legal Education (MCLE) Requirements?

Not all states require CLE credit hours. Check the chart to find the requirements for your state.

MCLE Approval Statuses:

ELI's 20th Annual Western Boot Camp on Environmental Law[®] is approved for CLE credit by Oregon, Pennsylvania, Texas, Washington, and Vermont.

Our applications for accreditation are pending as of April 30th, 2024 in California and Colorado. We will contact the attorneys who provided their Bar information during registration upon approval in their states.

MCLE States in which Boot Camp is NOT Pre-Approved:

Attorneys must apply for approval of the course using the state's application form or the Uniform Application. Most states also require **attachments** to the application, as noted on the application itself. These are usually: a copy of the program advertisement, timed agenda, biographies of speakers, and a Certificate of Attendance. The attachments you should need to include alongside your Certificate of Attendance are included in your virtual coursebook, which can be found at https://www.eli.org/boot-camp/western-supplemental-materials. If you have questions about a state's application or need an ELI staff member's signature, please email cle@eli.org.

Reciprocity

From our research, members of the Alaska, Connecticut, Florida, Hawaii, Maine, Montana, New Jersey, New York, North Dakota, and Wisconsin Bars *may* also be able to claim CLE credit for attendance, as the course has been accredited by another mandatory CLE jurisdiction.*

No MCLE

According to ELI's research, the District of Columbia, Maryland, Massachusetts, Michigan, and South Dakota Bars currently do not have mandatory continuing legal education requirements.*

*Please double check on your own to see if your state requires CLE or offers CLE reciprocity. State CLE policies change frequently, and ELI cannot guarantee that a state has not changed its policy since we conducted our research.

All attorneys should retain their records for at least 4 years after the date of Boot Camp in the event of an audit by their jurisdiction's regulatory authority.
